### 1. Principles of data processing

Personal data is any information relating to an identified or identifiable natural person. This includes, for example, information such as your name, age, address, telephone number, date of birth or email address.

Information for which we cannot (or can only with disproportionate effort) establish a link to your person, e.g. by anonymising the information, is not personal data. The processing of personal data (e.g. collection, retrieval, use, storage or transmission) always requires a legal basis or your consent.

Processed personal data will be deleted as soon as the purpose of the processing has been achieved and there are no longer any legally required storage obligations. If we process your personal data for the provision of certain offers, we will inform you below about the specific procedures, the scope and purpose of the data processing, the legal basis for the processing and the respective storage period.

### 2. Data collected during membership

#### A. Type and scope of data processing

We store the following data in the event of membership:

- First name/Name
- date of birth
- Street/House number
- PLZ/City
- E-mail
- Mode of payment
- Type of membership

If you issue a SEPA direct debit mandate, we collect the following data:

- account holder:in (first name and surname)
- credit institution
- BIC
- IBAN

## B. Legal basis

The processing of the personal data presented is based on your voluntary declaration of consent in accordance with Art. 6 Para. 1 lit. a DSGVO. As a membership contract with ToE e.V. is concluded by submitting the form for club membership, the processing of the personal data provided also serves to fulfil a contract between you and ToE e.V. or to carry out pre-contractual measures in accordance with Art. 6 Para. 1 lit. b DSGVO.

## C. Storage period

We store your membership data for a maximum of 6 years from the end of membership due to a statutory retention period. After that, all data will be deleted, unless the data has to be kept for 10 years for tax reasons.

## 3. Passing on data

We will only share your personal information with third parties if:

- you have given your express consent to this in accordance with Art. 6 para. 1 p. 1 lit. a DSGVO,
- if there is a legal obligation for the disclosure pursuant to Art. 6 (1) sentence 1 lit. c DSGVO,
- this is legally permissible and necessary according to Art. 6 para. 1 p. 1 lit. b DSGVO for the fulfilment of a contractual relationship with you,
- the disclosure is made in accordance with Art. 6 para. 1 p. 1 lit. f DSGVO on the basis of a legitimate interest of our association and there is no reason to assume that you have an overriding interest worthy of protection in the non-disclosure of your data.

## 4. Data security and backup measures

We are committed to protecting your privacy and treating your personal data confidentially. In order to prevent the manipulation, loss or misuse of your data stored with us, we take extensive technical and organisational security precautions which are regularly checked and adapted to technological progress.
